

What happens if my Delta flight is cancelled? ((Cancelled Booking Support))

If your **Delta flight is cancelled**, you are protected under both Delta's customer service commitments and U.S. Department of Transportation regulations, which guarantee passengers certain rights and options depending on the circumstances of the cancellation +1☎[855]☎738☎[4113].
